ASSUMPTION OF RISK AND WAIVER OF CLAIMS

I plan to attend the Association of Rehabilitation Nurses 2022 Rehabilitation Nursing Conference ("Conference"), which will take place September 19-23, 2022, at the Town & Country Resort San Diego, in San Diego, California ("Venue"). Those choosing to attend the Conference in person must agree to the terms of this Assumption of Risk and Waiver of Claims form ("Waiver").

I acknowledge that attending the Conference during the ongoing pandemic carries risk due to the contagious nature of the COVID-19 virus and the fact that the Conference will be held indoors with a large number of attendees. I have made the decision to attend the Conference in person with a full understanding of the inherent risks of such decision and agree as follows:

Any guests accompanying me to social events (Guests) and I will follow all health and safety guidelines, protocols, policies, regulations, and mandates relating to attendance at the Conference, including, but not limited to, United States Centers for Disease Control and Prevention (CDC) guidelines; federal, state, and local statutes, regulations, and other mandates applicable to the Venue; as well as any additional requirements imposed by ARN or the Venue (regardless of whether national, state, or local laws allow otherwise).

I represent and warrant that, at the time of my arrival at the Conference, any Guests and I will be fully vaccinated against COVID-19, having been administered the primary series of one or more of the following vaccines at least two (2) weeks prior to my arrival: Janssen Ad26.CoV2.S ("Johnson & Johnson"); Moderna (mRNA-1273); [Oxford/AstraZeneca (ChAdOx1-S (recombinant)]; and Pfizer BioNTech (BNT162b2).

We will monitor our own health status and will not attend the Conference if symptomatic of COVID-19 in any way (even if we are fully vaccinated against COVID-19) or if we believe we have been exposed to someone with COVID-19.

We are attending the Conference voluntarily and at our own risk. I understand that, by attending, my Guests and I risk being exposed to and/or infected with COVID-19 as a result of our actions or those of other attendees or participants, including, without limitation, ARN's officers, directors, members, staff, agents, and representatives (collectively, "ARN") and the Venue's employees. I hereby release, for myself, my heirs, and my personal representatives, as well as those of my Guests, and do forever discharge, indemnify and hold harmless ARN and the Venue from any and all claims, liabilities, actions, damages, costs or expenses of any kind arising out of, in connection with, or relating to attending or participating in the Conference, including, without limitation, any illness, damages, or injury resulting from travel to and from, and attendance at, the Conference, participation in events related to the Conference, exposure to an infectious disease (including COVID-19), or the manner in which the Conference or its related events and activities are conducted (collectively, "Claims"), whether a condition giving rise to any Claim occurred before, during, or after we attended or participated in the Conference.

I understand that my Guests and I will not be allowed to attend the Conference unless I agree to be bound by the terms and conditions of this Waiver and that my failure to comply with required safety protocols or follow the direction of ARN staff on site may result in the loss of my right to attend or participate in the Conference, including forfeiture of any registration fees paid.
